CONTEST REGULATIONS: "Primabiotic Global Ambassador"

§1 General Provisions

The contest is organized by **Natubay Sp. z o.o.**, with its registered office at ul. Hurtowa 2, 62-510 Konin, NIP: 667-177-04-61, REGON: 367139357, KRS: 0000671480, registered in the District Court of Poznań – Nowe Miasto and Wilda in Poznań, 9th Commercial Division of the National Court Register, with share capital of PLN 5,000.00, hereinafter referred to as the "Organizer".

The contest is governed by these Rules and the applicable laws in the United Kingdom. The contest will run from May 12, 2025, to July 11, 2025.

§2 Participants and Contest Rules

- 1. Participation in the contest is voluntary and free of charge.
- 2. The contest is open to any individual, hereinafter referred to as the **Participant**, who:
 - a. Has read and accepted these Rules and has given consent for the processing
 of personal data for the purpose of conducting the contest by submitting an
 entry;
 - o b. Is over 18 years old and has full legal capacity;
 - o c. Resides in the United Kingdom;
 - o d. Has an Instagram account;
 - e. Completes the Contest Task.
- 3. Only individuals meeting the conditions set out in §2(2) are eligible to participate.
- 4. Employees of the Organizer, as well as employees and representatives of entities providing services to the Organizer in organizing the contest under civil law contracts, and their immediate family members (spouses, ancestors, descendants, siblings) are excluded from participation.
- 5. **Contest Task**: The Participant must write a comment under the contest post answering the question:

- 6. Each Participant may submit multiple entries (in separate comments).
- 7. The Organizer reserves the right to remove and ignore contest entries from authors who:

 - o d. Violate Instagram's terms of service;
 - e. Include offensive language, pornographic content, or content promoting racial, ethnic, or religious hatred or discrimination against social groups in their entries.
- 8. By participating, the Participant agrees to have their contest entry shared on Primabiotic's social media profiles.

§3 Rights to Contest Entries

- 1. The Participant guarantees that their entry does not infringe any rights or interests of the Organizer, its service providers, or third parties, including intellectual property rights and personal rights.

- 1. The Organizer will appoint a **three-member Contest Commission** responsible for overseeing the contest, interpreting the rules, and selecting the winner(s). The Commission's decisions are final, without prejudice to the Participant's right to pursue claims under applicable law.
- 2. After the contest ends, the Commission will evaluate entries based on **attractiveness**, **originality**, **and creativity**.
- 3. **One** (1) **Winner** will be selected.
