CONTEST REGULATIONS: "Primabiotic Summer Edition"

§1 General Provisions

- 2. This contest is governed by these Rules and the applicable laws of the United Kingdom.
- 3. The contest will run from July 18, 2025, to July 21, 2025.

§2 Participants and Contest Rules

- 1. Participation in the contest is voluntary and free of charge.
- 2. The contest is open to any individual, hereinafter referred to as the Participant, who:

a. Has read and accepted these Rules and has given consent for the processing of personal data for the purpose of conducting the contest by submitting an entry;

- 3. Only individuals meeting all the above conditions are eligible to participate.
